Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, as per NCH Act 2020 and its relevant regulations. As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 Performa were examined by the Medical Assessment and Rating

2. On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls

a) Hospital Faculties

Average Bed Occupancy per day (Percentage) -14.71% against the requirement of 30% bed occupancy.

b) Teaching Faculty-

- Separate list of UG and PG faculty not given. College is directed to furnish department wise list of teachers for UG and PG departments with list of guides and allocation of seats made for PG Scholar. College should fulfill requirement of PG and UG faculties as per regulation under NCH Act 2020
- Guest Faculty: Modern Medicine consultants are included in the list of guest Faculty.

c) Miscellaneous-

- College teaching staff list shows teacher 35 as fulltime faculty out of which acquaintance roll is not given for 11 faculties.
- The college has shown the bed occupancy for the last calendar year as 14.71%. Though due to covid situation IPD/OPD status are not considered for permission process, this needs to be tremendously enhanced considering the status of the PG educational Institute in Homoeopathy . You are required to take necessary measures for improvement of

OPD/IPD and the status of the same shall be apprised to MARBH within 3 months from the date of issue of this letter.

- 4. After considering the provisions of NCH Act, 2020 and its relevant regulations permission of the Medical Assessment and Rating Board is issued to Dr V.H Dave Homoeopathic Medical College and Smt S. I. Patel Homoeopathic Hospital Hahnemann House, Amul Dairy Road, Anand -388001, Gujarat for conducting BHMS course with 125 seats and MD(Hom) Course with 09 seats (Organon of Medicine with Homoeopathic philosophy-03 seats, Materia medica-03 seats and Repertory-03 Seats) for the academic year 2022-2023.
- 5. All admissions in Under Graduate course shall be through NEET/AIAPGET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.
- 6. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board as per Rules. The College has to comply with the full requirements as per NCH Act, 2020 for conducting the course.
